Punta del Cobre S.A. (Pucobre) finalized the acquisition of Pacífico V Región S.A. in a reverse merger under which Pucobre absorbed its parent company Pacífico.

The transaction is subject to customary closing conditions.

Pucobre is a company dedicated to the extraction of copper in the Atacama Region, northern of Chile. It also has two projects under development: Tovaku, in the Antofagasta Region and El Espino, in the Coquimbo Region. Pucobre was founded in 1989 and is headquartered in Santiago de Chile.

Pacifico V Region SA through its affiliate extracts and processes copper in leaching plants throughout Chile. The company, led by Gonzalo Ibanez Langlois, Jose Nicolas Hurtado Vicuna and

Diego Errazuriz Vidal, recorded \$230 Million Revenues.
