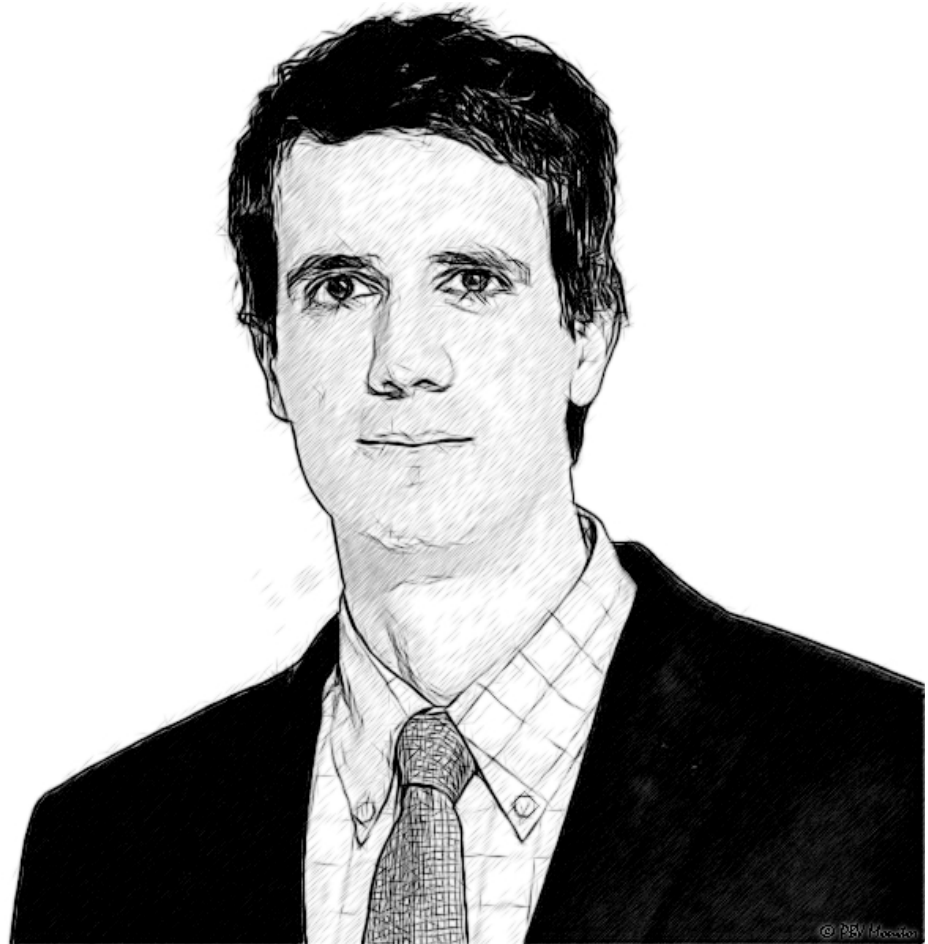

# Banchile's \$44.4 Million Acquisition of 49% stake in Arauco Express
